Like many thousands of people across the world, I am following the progress of this process closely. I urge you to make Port Harcourt a leader in city redevelopment by choosing to develop the city in a way which is in line with international human rights standards.

Regeneration programmes that proceed with respect for human rights are likely the most sustainable and successful. It is ordinary people that make these plans succeed. A development process that is participatory, that involves genuine consultation with those directly impacted and that draws on the resources and potentials of the waterfronts is not only a requirement under international human rights law but it would add tremendous value to regeneration initiatives across the city and the region.

Such an approach would also support Nigeria's commitment to the UN Millennium Development Goals (MDGs), specifically to reduce the number of people living in slums by 2020 (Goal No. 7, Target 11).

I urge you to stop further forced evictions and instead make Port Harcourt a world leader in city redevelopment by choosing to develop the city in a way which is truly in line with respecting the human rights of the people of Port Harcourt.
